Did the nominee inspire others to adapt similar practices? If this is a research project – has it influenced public policy? What makes this nominee stand out as an EcoHero? *(200 words – point form accepted).*

COMMITMENT: How did the nominee exemplify dedication and hard work? Provide the history of the nominated project, initiative, or person. How many years has the nominee been actively pursuing their environmental goals? What barriers were overcome to achieve success? Describe the outcome of the nominee's work and the impact it has had on others. *(200 words – point form accepted).*

OUTREACH: How did the nominee inspire others? How did the nominee extend outside their four walls to positively impact others with their work? How were the project results shared? Did the project educate or lead by example in order to change attitudes of specific target audiences? Did they collaborate with other organizations and individuals from other sectors? How can the project stand as a prototype for future projects? *(200 words – point form accepted).*

SUPPORT: Why should the nominee receive an Emerald Award? Feel free to use your creativity in your response and highlight anything that you feel may have been missed in the previous sections *(200 words – point form accepted).*
